Primaries Set General Election Stage: Bailey vs. Pritzker Moderate candidates for both parties had tough primary election day

In Illinois' first-ever June primary, candidates who campaigned and/or governed in the

center found it challenging to win over their party's voters.

Voters in the Republican primary nominated **Darren Bailey for Governor**, while Republican incumbent **Congressman Rodney Davis** lost his primary election to fellow member of Congress **Mary Miller**. In addition, Republican State House members and Rebuild Illinois supporters **David Welter** and **Mark Luft** also lost primary elections.

Voters in the Democrat primary supported Congressman Sean Casten over fellow member of Congress Marie Newman. In a new congressional seat, Democrat voters selected State Rep. Delia Ramirez over long-time industry supporter and current City of Chicago Alderman Gil Villegas. In the State House, Democrat State Representatives who supported Rebuild Illinois were defeated in their primaries, including Rep. Mike Zalewski, Rep. Kathleen Willis and Rep. Denyse Stoneback.

Also defeated in this wave against centrists, was ACEC-IL member **Sam Kukadia** in his efforts to secure the Democrat nomination for Cook County Commissioner.

What does this mean for November? Republican Darren Bailey campaigned hard against the Rebuild Illinois funding mechanisms. we can expect a lot of rhetoric challenging investment in infrastructure and predictably calls to roll it back in his campaign to unseat incumbent JB Pritzker.



Strike Begins to Slow Work

The Operating Engineers Local 150 strike against three material companies has now entered its fifth week. The estimated 300 employees who have gone on strike has created a ripple effect across the industry as other unions have joined with OE 150 in the strike and work stoppage, creating a statewide lack of supply of aggregates, slowing and or stopping work especially in the Chicago-metro region.

According to an **Illinois Roadbuilder** survey, if the strike continues beyond July 4, one-third of respondents will not be able to complete ongoing jobs by the end of the construction season, while another 53 percent are unsure if they will be able to complete those jobs.

Last week, IDOT sent letters to the three firms stating that "the Illinois Department of Transportation has no choice but to act in the best interests of the state and our taxpayers. This includes the possibilities of suspending awards from the June letting and revisiting whether to go forward with the upcoming July letting." IDOT also added "the department reserves the right to explore using alternative mix designs to ensure the continuity of our projects. The department will not bear any responsibility or cost for increased expenses experienced because of the strike."

There had been discussions of a possible General Assembly Special Session where legislative action could be considered to require prevailing wage for this classification of worker, but the Governor indicated yesterday that a Special Session is not imminent.

Gov. Pritzker Signs Legislation to Modernize Infrastructure Improvement Process



Governor's Announcement

Gov. JB Pritzker signed into law legislation allowing for the implementation of design-build project delivery, an efficient, alternative method for completing the state's infrastructure improvements.

<u>Senate Bill 2981</u> creates the Innovations for Transportation Infrastructure Act, authorizing the

Illinois Department of Transportation (IDOT) and the Illinois Tollway Authority to adopt the use of the design-build delivery method on highway construction projects. IDOT currently utilizes the design-bid-build project delivery method in which the department designs a construction plan, then reviews bids from contractors. Design-build would create a more efficient process, allowing a single contractor to handle both design and construction of the project. Any projects that adopt this method would be capped at a combined total of \$400 million.

"Illinoisans deserve modernized infrastructure on a timely basis," said Governor JB Pritzker. "A design-build delivery method won't just save taxpayers money—it will streamline our construction process and deliver the infrastructure improvements that our state requires. With this legislation, our Rebuild Illinois investment plan will be expedited in a time-efficient, cost-effective, and equity-based manner. I am proud to sign this bipartisan bill into law thanks to our legislative partners' foresight and advocacy."

"Streamlining the implementation of infrastructure projects will save taxpayer dollars and rebuild our roads, bridges and mass transit systems in a transparent and equitable manner," said State Senator Ram Villivalam (D-Chicago). "Finding alternative ways to deliver on the Rebuild Illinois capital plan remains a top priority for me as chair of the Senate Transportation Committee."

"Providing IDOT and the Tollway the authority to utilize alternative delivery methods like design-build will responsibly expedite construction projects, with the goal of producing more jobs for Illinois workers and shorter construction times for Illinois commuters and businesses," said Kevin Artl, President and CEO of the American Council of Engineering Companies of Illinois. "ACEC-IL and its members are proud to have championed SB2891 and applaud the General Assembly and Governor Pritzker for their great work on this legislation."

The Innovations for Transportation Infrastructure Act also authorizes IDOT and the Tollway to use the construction manager-general contractor delivery method on at most two projects per year. In adopting this method, the department would contract with a single contractor to serve as the construction manager for the design phase, then agree on a price to serve as general contractor for construction.

Additionally, the act requires IDOT and the Tollway to ensure full participation for minority and women-owned businesses by implementing separate goals for design and construction, bid-shopping protections, and requiring independent construction managers for projects costing over \$30 million



ACEC Pushes Back Against Federal Gas Tax Holiday Discussion

ACEC joined with the US Chamber of Commerce and many other stakeholder organizations in opposition to President Biden's expected announcement today calling on Congress to pass legislation to suspend the federal motor fuels tax for three months.

ACEC also issued the following statement:

"There are several initiatives the Administration could take to provide very meaningful and long-term relief for consumers facing rising gas prices but suspending the federal gas tax is

not one of them. The minimal relief from a gas tax holiday will be temporary and such action will undercut the new infrastructure program that will play such a critical role in restoring economic growth. What's needed is increased refining capacity and new sources of oil from North America, which will provide long-term relief and maintain the bridge we need as the energy economy continues its transition to renewable sources of energy. We are also concerned where the 'other revenues' could be found to offset any proposed 'holiday.' There is already a user fee that provides a dedicated stream of revenue, and we oppose any attempts to further erode confidence in the Highway Trust Fund."



IDOT Appointments

IDOT Secretary Omer M. Osman announced the appointment of **Elizabeth Irvin** as Deputy Director of Planning and Programming for the Illinois
Department of transportation. Irvin recently served as a Senior Transportation
Analyst at the Union of Concerned Scientists. She received a Bachelor of Arts
at Williams College and a Master of City Planning at Massachusetts Institute of

Technology. In her new role, she will be focused on implementing the sustainable aspects of recent state and federal legislation.



IDOT Secretary Omer M. Osman announced the appointment of Alice Rivera-Alfaro as Bureau Chief of Small Business Enterprises for the Illinois Department of transportation. Rivera-Alfaro recently served as Chief Financial Officer and Diversity, Equity, and Inclusion Counsel and was formerly Assistant Procurement Counsel for the State of Illinois Executive Ethics Commission (EEC). She received a Bachelor of Science in Accounting from the University of Illinois at Chicago, a Master of Business Administration in Finance from Argosy University, and a Juris Doctor from

the Inter-American University of Puerto Rico, School of Law.

Other News of Note

Will County's Five-Year Transportation Improvement Program, providing a multi-year plan for countywide infrastructure investments, has been officially approved by the Will County Board. The Will County Division of Transportation presented the plan, which will provide over 20 miles of improved highways, 30 reconstructed intersections, and 10 rehabilitated or replaced structure. More

Transit agencies in downstate Illinois can now apply for a final round of grants as part of the Rebuild Illinois Transit Capital Grant Program. The third and final round of proposals will be accepted through July 29 from downstate transit providers. The state will then determine how it distributes up to \$132 million for projects expanding and improving transit service. **More**

The Illinois Department of Transportation announced today that major projects to modernize and improve Interstates 24 and 57 in southern Illinois are planned or underway. Ten major projects on both Interstates combined represent a total investment of more than \$350 million. Once everything is completed, 29 miles of I-57 will have been widened to three lanes in each direction while 35 miles of I-24 will be resurfaced. **More**

The U.S. Department of Transportation's Federal Highway Administration today opened a call for applications through a **Notice of Funding Opportunity** for the competitive Bridge Investment Program. The program will provide \$12.5 billion over five years, with nearly \$2.4 billion available in Fiscal Year 2022. **More**

The Federal Highway Administration issued a <u>notice of proposed rulemaking</u> on June 9 to outline minimum standards and requirements for projects funded via the five-year \$5 billion National Electric Vehicle Infrastructure. That rulemaking seeks to support the build out of a national EV charging network of 500,000 EV chargers by 2030. <u>More</u>





Bipartisan Policy Center's DAC Day

The Infrastructure Investment and Jobs Act (IIJA) allocated \$12.17 billion for direct air capture (DAC) and carbon management over the next five years. \$3.5 billion of that funding will be used for the development of four new DAC hubs. The Bipartisan Policy Center (BPC) held its annual DAC day on June 22, 2022. Speakers included Senator Sheldon Whitehouse (D-RI), Senator Bill Cassidy (R-LA), and Kelly Cummins, principal deputy director of the Department of Energy (DOE) Office of Clean Energy Demonstrations.


DOE has issued a notice of intent (NOI) regarding the selection process of the hubs, which can be downloaded here. The funding mechanism is through grant or cooperative agreements and recipients may include technology developers, utilities, universities, national laboratories, engineering and construction firms, state and local governments, tribal environmental groups, and community-based organizations.

The exact locations for the new developments have not been released but the funding is expected to be issued in Q4 FY2022. We also know that at least two hubs will be developed in high fossil-producing regions. The top five coal-producing states are Wyoming, West Virginia, Pennsylvania, Illinois, and North Dakota, according to the U.S. Energy Information Administration. The top five crude oil producers are Texas, New Mexico, North Dakota, Alaska, and Colorado, according to Statista.

DAC hubs are necessary components to reach net-zero emission goals and can very well be the next breakthrough in technology that drives an industrial revolution. According to BPC these hubs can integrate the power, transportation, manufacture, and infrastructure sectors together.
