### ACEC: Leading the Way in Springfield

Components of ACEC Illinois' legislative agenda are now advancing through the legislature as the General Assembly closes in on its final month and a half of scheduled session days before May adjournment.

**ACEC** legislation to streamline the land acquisition process for IDOT and Tollway received unanimous support in the Illinois Senate and now heads to the House for approval.

<u>Senate Bill 2424</u>, sponsored by Senator Villivalam and Senator DeWitte, would require that land acquisition services be procured via qualification based selection (QBS). QBS has proven to deliver best value to agencies and also taxpayers. The legislation would allow for experienced firms to develop scope and work in more fluid consultation with both IDOT and Tollway to expedite land acquisition for pending projects. The legislation is now in the House and is being sponsored by **Representative Rashid**.

The Illinois Senate Revenue Committee held hearings on SB 2084, the State Innovation Tax Credit.

SB 2084, developed by ACEC Illinois, creates a State of Illinois innovation tax credit that would be administered by the Department of Revenue, rather than the IRS, aiding in the state's goal of attracting more research and development programs to Illinois. This legislation is sponsored by Senator DeWitte. ACEC Illinois President Kevin Artl testified before the committee on how the legislation would assist firms in expanding investment in R&D while providing options for firms who find the federal R&D tax credit process too burdensome or risky.

The Illinois House Revenue Committee is held a hearing on ACEC legislation aimed at helping Illinois engineering firms recruit and retain recent Illinois college graduates. The Retain Illinois Students of Engineering (RISE) Tax Credit (HB 2425). The legislation is focused on helping attract and retain engineers as the industry faces a shortage of educated talent, this legislation provides for a tax credit of 10% of the salary paid to recent graduates of Illinois' engineering schools and 5% of the salary paid to recent graduates of engineering schools outside of Illinois. This legislation is sponsored by Rep. Marty Moylan.

### **Congressional Update: Fixing R&D Takes Center Stage**

Senators Maggie Hassan (D-NH) and Todd Young (R-IN) introduced S. 866, legislation that would repeal the R&D amortization requirement. Here is the current list of cosponsors.

During the ACEC Illinois Board of Directors trip to DC, fixing R&D was a top point of discussion with Cong. LaHood, Cong. Krishnamoorthi, Cong. Budzinski and the offices of Senator Durbin and Senator Duckworth.

**IDOT Updates** 

Illinois Department of Transportation

ACEC Illinois has created a "lump sum" task force to work with IDOT on developing a pilot program for lump sum contracting. Meetings are ongoing as Task Force members share best practices and implementation processes with IDOT leadership.

ACEC Illinois' Financial Management Committee has been meeting with IDOT Audit to discuss ways to streamline and expedite the SEFC process.

ACEC Illinois was provided a debrief from IDOT and CTA leadership on their Mega-Project grant application for the I-290/Blue Line Modernization Project. ACEC IL has recommended a larger state commitment to fund much of the initial mainline work to allow for greater flexibility on future grant applications.



Last month, the Illinois Tollway held its *Move Illinois* Quarterly meeting. The Tollway provided information on the capital program, diversity initiatives and upcoming PSBs. <u>Click here to view the entire presentation</u>.

The Tollway also invited ACEC Illinois DBE and DEI Committee Chairs Raymond Kumapley and Duana Love along with additional committee members to participate in roundtable discussion on Tollway DBE efforts.

### Welcome Back!

Governor JB Pritzker announced that **Bria Scudder** will serve as Deputy Governor for Public Safety, Infrastructure, Environment, and Energy.

Scudder previously worked in the Governor's Office as First Assistant to Christian Mitchell, the former Deputy Governor. Mitchell stepped down from his role earlier this month.

As First Assistant, Bria Scudder was actively engaged with ACEC Illinois members, participating in briefings and attending ACEC events, including EEA and our awards lunch with Governor Pritzker. We are excited that she has returned to state government.

### In the News

### State Update

Governor Pritzker was in Decatur last week to announce \$200 million in grants supporting 22 freight mobility projects. The \$200 million comes from federal funds. <u>More</u> CMAP has begun the process of putting together recommendations for Chicago's transit

agencies, as directed by legislation passed last year by Rep. Eva Dina Delgado. The legislation tasked CMAP with recommendations for addressing regional transit problems in the Chicago area, including the funding challenges brought on by COVID. <u>More</u>

#### Federal Update

The House Transportation and Infrastructure Committee held a hearing this week on the implementation of the Bipartisan Infrastructure Law (BIL)/Infrastructure Investment and Jobs Act (IIJA). Representatives from the American Association of State Highway and Transportation Officials, the National Stone, Sand, and Gravel Association, the Associated Builders and Contractors, and the American Road and Transportation Builders Association testified.

Key points from testimony were (1) the BIL/IIJA is already making a difference in improving the nation's infrastructure (34,700 new projects through Jan. 30, 2023), (2) inflation has a significant impact on infrastructure projects, and (3) the FHWA guidance that states need to determine their own infrastructure priorities, which rescinded the "fix it first" memo from December 2021. <u>More</u>

Congressman Mike Bost (IL) and Congresswoman Angie Craig (MN) introduced legislation to increase available truck parking around the country through \$755 million in competitive grants. <u>More</u>

President Biden's choice to lead the Federal Aviation Administration withdrew over the weekend in the face of Republican opposition to his nomination. The FAA has not had a confirmed Administrator since March 2022. <u>More</u>


### What do you enjoy doing in your spare time?



### Strategies for Preventing Emotional Exhaustion and Burnout

In the post-pandemic world, regular news reports highlight how more Americans are experiencing stress and anxiety from the pressures of daily life. The American Institute of Stress defines stress as "physical, mental, or emotional strain or tension." Stress affects how we think, act, and feel. Stress affects individuals differently. Stress causes chemical changes that affect our major physical, mental/cognitive, and emotional systems and social responses.

Burnout can result from chronic unresolved stress and can cause or contribute to distress leading to an emotional "overload." In March 2020, Gallup reported on the <u>Causes and</u> <u>Cures of Employee Burnout</u>. <u>This[CB1]</u> report focused on burnout as "a symptom of modern workplaces that are increasingly fast-paced, complex, and demanding." This aspect of burnout has been frequently written about in terms of workers achieving necessary balance between work-life and home-life responsibilities.

The traditional view of burnout in the workplace assesses factors like role clarity, workload, number of hours worked, flexibility, and autonomy in one's work, and relationships between workers and managers. The hallmark signs of burnout are pessimism and cynicism expressed as self-doubt, a sense of failure, and feelings of decreasing effectiveness at work combined with decreasing satisfaction and sense of accomplishment at work.
