3. **Evaluation of Applicants:** The evaluation of the applicants will be made by the Emerging Professional Awards Subcommittee of the Engineering Excellence Awards Committee.

 - b. The applicant should have 15 years or less working in the industry.
 - c. The applicant should be involved with ACEC Illinois
