#### State & Federal Update

#### ACEC Illinois Defeats Effort to Weaken State QBS Law

Our grassroots lobbying campaign defeated a bill that would have weakened the state's QBS law.

Over the course of two weeks, our grassroots website helped generate over 2,000 messages to lawmakers asking them to oppose the legislation. Our public relations campaign garnered statewide media hits from engineers outlining the danger of weakening QBS.

As part of the effort, ACEC Illinois Board Chair Orhan Ilgaz, principal of 2IM Group had a letter published in Chicago's Daily Herald newspaper, in which he laid out the argument against the bill:

"Gutting Qualifications-Based Selection (QBS) standards could result in less qualified teams designing and engineering our state's most vital public infrastructure. More than just roads, bridges and railways, public infrastructure includes the facilities that clean and treat our drinking water, the nuclear sites that produce the energy that powers our homes and businesses and the schools, senior care facilities and hospitals that care for our loved ones."

"Settling for anything less than the most qualified professionals for this important work risks the safety and dependability of our public infrastructure. HB 680 is a risk that Illinois cannot afford to take."

Due to the high-level of engagement by ACEC Illinois members in our statewide lobbying efforts, the sponsor of the bill declined to call it for a vote, and the legislation was re-referred to the House Rules Committee, all but ensuring it will not be called for a vote this year.

ACEC awarded a Minuteman Grant to the Member Organization to assist in the lobbying effort.

Electronic Signature Legislation Receives Unanimous Support

ACEC Illinois drafted legislation to ensure IDOT, Tollway and CDB continue to have the authority to accept electronic signatures was approved unanimously by the Senate. The legislation, sponsored by State Senator Ram Villivalam, now heads to the House for approval. A similar measure in the House, sponsored by State Representative Marty Moylan, also secured unanimous approval.

#### ACEC Illinois and TFIC Beginning to Focus on State Budget

ACEC Illinois joins with TFIC in proposing that a small portion of the \$7.5 billion COVID relief funding from the federal government be used to replace the \$224 million in transportation spending cuts proposed by the Governor in his February budget address. Specifically, we ask the General Assembly to honor its commitments to transportation investment made as part of the 2019 Rebuild Illinois program negotiation and:

- Honor the Rebuild Illinois plan to move sales taxes on motor fuel into the Transportation Renewal Fund (\$72 million)
- Continue to support transit operations through General Revenue Funds, rather than the Road Fund (\$100 million)
- Eliminate the 90% proration of the State's commitment to the Regional Transportation Authority (\$52 million)

ACEC Illinois will join the TFIC lobbying effort to ensure the final budget reflects the legislative commitment to the Rebuild Illinois Capital Program.



# ACEC Illinois Board Meets with Congresswoman Marie Newmane

ACEC Illinois' Board met with Freshman Cong. Marie Newman and discussed the track of a national infrastructure bill along with PPP fixes. Cong. Newman serves on the House Transportation and Infrastructure Committee and the House Small Business Committee. In terms of a national infrastructure bill, Cong. Newman believed the legislation would go to mark-up this month (May) and could ultimately head to the Senate by the July 4 holiday.

As for a PPP fix, Cong. Newman is working with colleagues to develop options for a full-waiver, she was sympathetic to the position the engineering industry is placed in regards to PPP and will continue to work with us for a solution.



#### U.S. DOT Secretary Pete Buttigieg Calls for Passage of Infrastructure Bill by Memorial Day

Addressing the ACEC Annual Convention this morning, U.S. Transportation Secretary said passing a comprehensive infrastructure package this year is "a once-in-a-lifetime opportunity." He called on Congress to put together and pass legislation by Memorial Day.

Calling himself an "infrastructure enthusiast," Buttigieg said we are "in a perfect storm...of demonstrated need, bipartisan support among the people, leadership in Washington, and a climate

that is calling on us to act."

He said the \$2.25 trillion American Jobs Plan isn't "just proposing to build back to where we were in 2019. This is about looking ahead to the next 50 years. Climate change and equity and built into every part of this plan."

Buttigieg stressed that there is enormous bipartisan support among the American people for robust infrastructure investment, and said he was enthused by the Senate Republicans' \$568 billion infrastructure proposal.

"If there is any area for bipartisan cooperation on Capitol Hill, this has to be it," he said. "We have a counterproposal on the table and now we're off to the races with negotiations."

#### Bi-Partisan Infrastructure Talks Heat Up in Senate

U.S. Senator Joe Manchin continues to push for a bipartisan approach to infrastructure investment, making it difficult for the Democrats to push through their version of infrastructure investment. Manchin and a group of other senators are quietly developing a proposal that is more limited than that put forth by President Biden. The more limited proposal would focus on roads, bridges, railways and broadband. More on that here.

#### **Industry Updates**

#### **IDOT PPP Update**

There is no doubt that we have all been frustrated by the lack of progress at the Federal level to provide a complete, national fix to this problem. However, our conversations at the State level have been constructive and collaborative. ACEC IL has had continuous, productive meetings with IDOT on the issue of PPP and the application of the FAR Credit Clause.

Given that PPP loans were a Federal program, ACEC IL held the position that if the FAR Credit Clause were to apply to any contracts, it should be limited to those that utilized Federal dollars. In addition, subsequent guidance issued by the FHWA only referenced Federally-funded contracts as subject to FAR Credit Clause.

As a result of these continued, collaborative discussions with IDOT, they have agreed to limit the scope of the FAR Credit Clause to only Federally-Funded Engineering Contracts.

IDOT's decision closely mirrors FHWA guidance and significantly limits the scope of IDOT contracts subject to the FAR Credit Clause. For instance, in looking at the 268 IDOT engineering projects advertised from 2018-2019, only 38% were likely funded with Federal dollars.

We will continue to work for a complete waiver at the Congressional level, but we do believe IDOT, given their current constraints and FHWA guidance, has developed a fair, reasonable and equitable approach to the PPP/FAR Credit Clause issue for Illinois firms.

Moving forward, IDOT will be in consult with ACEC IL about implementation guidance and once that is finalized, we will share that with you. Also, while it is not the official list, if you want to determine which engineering contracts may have had Federal funding, visit the specific job advertisement on IDOT's PTB page. If the job description lists that "This project may contain Federal Funds" there is a great likelihood it did have Federal funds.

#### Tollway I-490 Update

ACEC Illinois joined Tollway leadership and Cong. Raja Krishnamoorthi for an I-490 briefing and tour.

#### ABC Ch-7 covered the event, here's a highlight of their coverage

"That's a big deal because we are finally allowing people to connect from I-90 all the way down to the southern suburbs without having to go through the airport corridor, and that's going to help in a lot of ways. It's going to save congestion, it's going to save fuel, it's going to save money," said Rep. Raja Krishnamoorthi of the 8th District.

Local leaders got a tour of the I-490 progress Thursday, including the large amount of work that got done in the past year during the stay-at-home mandates and social distancing.

There will be 15 ramps that make up the I-490 and Route 390 Interchange.

Along with the progress being made at the I-490/Route 390 Interchange, there is also construction in place at the I-490 Interchange with I-90, the Jane Addams Tollway and at the former site of the old Des Plaines Oasis.

There are several years to go until the new corridor is complete. The ramps will open first. While the project will make it easier to access O'Hare, there are also benefits to the surrounding suburbs.

"This project is going to provide significant congestion relief. I mean there's 86% of the roads in this area are considered congestion, that they experience severe congestion. This project is going to relieve a lot of that," Illinois Tollway Acting Chief Engineering Officer Manar Nashif said. The project also includes local road improvements and wide-reaching economic development that is expected when it is completed. It is scheduled for completion in 2026.


