#### ACEC Illinois Participates in Governor's Infrastructure Meeting

Governor Pritzker's policy team asked ACEC IL to participate in an infrastructure stakeholder meeting last week. During the policy meeting, ACEC IL outlined key issues including workforce challenges, program delivery and the continuity and stability of funding streams for infrastructure.

In addition, ACEC IL has been appointed to serve on the legislature's procurement task force to develop ways to enhance knowledge transfer between the consultant community and state agencies while also streamlining the procurement process.



#### FHWA Approves IDOT EV Plan

The Illinois Department of Transportation announced that the Federal Highway Administration has approved its plan to build a reliable electric vehicle charging network throughout the state. The State of Illinois Electric Vehicle Infrastructure Deployment Plan addresses potential challenges and proposes locations for charging stations to ensure motorists can confidently traverse the state in electric vehicles.

Illinois' plan provides a framework for implementing the National Electric Vehicle Infrastructure (NEVI) program, a provision of the Infrastructure Investment and Jobs Act. Illinois will receive more than \$148 million in federal funding from

NEVI over the next five years to build out a network of public EV charging stations across the state

In accordance with NEVI requirements, funding will be used to build EV charging stations at least every 50 miles along designated Alternative Fuel Corridors. The stations will be located no more than one mile off the designated corridor and will allow four average-range vehicles to fully charge at once in less than 30 minutes. Preliminary estimates indicate a need for a minimum of 20 stations. A map of proposed sites is included in the Illinois Electric Vehicle Infrastructure Deployment Plan.

As a next step in implementing the EV Infrastructure plan, IDOT is developing a Request for Information to gather information from potential vendors of equipment and host sites for EV chargers.

Finally, IDOT will be hosting stakeholder meetings throughout the remainder of 2022. These meetings will be open to the public where people can learn more about the program and provide feedback. More detail on these meetings will become available as they are scheduled. Recording of previously held public meetings can be found on IDOT's website.

# **Understanding the Illinois Site Remediation Program**



SRP is the industry abbreviation in Illinois for "Site Remediation Program" which refers to a body of law and regulation pertaining to contaminated properties. It describes a regulatory program where a landowner can voluntarily investigate and/or remediate their property to receive a NFR (No Further Remediation) letter. The Illinois EPA is authorized to issue No Further Remediation (NFR) letters to the Remedial Applicants who have successfully demonstrated, through proper investigation and, when warranted, remedial action, that environmental conditions at their remediation site do not present a significant risk to human health or the environment. The NFR letter signifies a release from further responsibilities under the Illinois Environmental Protection Act.
