### Senate Begins to Consider Bi-Partisan Infrastructure Agreement

On Wednesday, the Senate voted 67-32 to advance debate on the \$550 bipartisan infrastructure bill. Hours before the vote, a bipartisan group of senators announced an agreement with President Biden on the package of supplemental funding across a range of capital accounts.

The legislation is also expected to include committee-passed versions of bills to reauthorize surface transportation programs for five years, coupled with additional appropriations for various programs and initiatives.

### Highlights:

**Roads, Bridges** —\$110 billion, including \$40 billion for bridge rehabilitation and replacement, and \$17 billion for major projects; also includes reauthorization of federal highway programs for the next

five years, as approved by the Environment & Public Works Committee.

**Public Transit** —\$39 billion in funding above the current budget baseline, including state-of-good repair and capital investment grants, as well as five-year reauthorization of public transit programs.

**Rail** —\$66 billion in supplemental funding, including \$24 billion for federal-state partnership grants for Northeast Corridor modernization, \$12 billion for intercity passenger rail improvements, including high speed rail projects, and \$22 billion for Amtrak.

**Transportation Safety**—\$11 billion for transportation safety, attention to reduction of fatalities (cyclists and pedestrians).

**Energy Grids**—\$73 billion for power grid upgrades including new transmission and research for new technologies (nuclear reactors and carbon capture).

**Electric Vehicles** —\$7.5 billion to build a national charging station network for electric vehicles.

**Airports**—\$25 billion for airport improvement projects, including both airside (runways, taxiways) as well as terminal projects.

**Ports and Inland Waterways**—\$17 billion for waterway and coastal infrastructure, inland waterways, and port infrastructure.

**Resilience, Climate Change**—\$50 billion to address cyber-attacks, effects of climate change including droughts and floods.

**Drinking Water**—\$55 billion for drinking water, including replacement of lead pipes and removal of emerging contaminants.

Broadband Internet—\$65 billion for broadband deployment.

**Environmental Spending**—\$21 billion for environmental remediation including Superfund sites; \$1 billion to reconnect communities divided by past infrastructure projects.

**Revenue Raisers**—\$588 billion in revenue offsets include the following provisions:

- \$205 billion in repurposed Covid relief funds.
- \$56 billion in "economic growth resulting from a 33 percent return on investment in these longterm infrastructure projects."
- \$13 billion from reinstating certain Superfund fees.
- \$50 billion from "recouping fraudulently paid" federal unemployment benefits.
- \$53 billion from "certain states returning used enhanced federal UI [unemployment] supplement."
- \$6 billion in sales from the Strategic Petroleum Reserve.
- \$2.9 billion from extending available interest rate smoothing options for defined benefit pension plans.
- \$20 billion from sales of future spectrum auctions and \$67 billion from the proceeds of the Feb. 2021 c-band auction.
- \$49 billion from delaying the Medicare Part D rebate rule.
- \$28 billion from "applying information reporting requirements to cryptocurrency (JCT score)."
- \$21 billion from extending fees on GSEs.
- \$8.7 billion from the mandatory sequester.
- \$6 billion from extending customs user fees.
- \$3 billion in savings from reducing Medicare spending on discarded medications from large, single-use drug vials.

The \$1 trillion plan should provide money to rebuild roads and bridges, expand O'Hare, modernize Union Station, replace lead water pipes, extend the Red Line and much more.



Crain's Chicago Business: IDOT, Chicago Poised To Do Well in Infrastructure Bill

#### From Crain's:

Overall, according to a summary prepared by Washington business lobbyists that was passed on to me, the plan calls for spending \$1 trillion on physical infrastructure projects over the next five years—\$550 billion of that new and above current sending levels.

Here's who gets what:

**Roads and Bridges:** With an additional \$55 billion allotted nationally for roads and bridges, the Illinois Department of Transportation is line for perhaps \$2 billion of that. That assumes that state gets its usual share of 3.6 percent of such spending nationally.

**Transit:** Not only the CTA but Metra and Pace are to be eligible to compete for \$39.2 billion for capital work, apparently the largest single infusion of federal cash in U.S. history. The Chicago region seems likely to get \$3 billion to \$4 billion, but much of the money will be competitively awarded rather than by formula, so it's difficult to tell for sure. Potential winners include several Metra projects, the ongoing reconstruction of the CTA's Red Line north and capacity expansion of the CTA Blue Line to O'Hare as well as the Red Line South extension, but some of those may have to compete against each other.

**Airport terminal projects** nationally are to get a new \$5 billion, with an additional \$15 billion in money awarded to airports by formulas. O'Hare's ongoing \$8.5 billion terminal expansion and renovation project may well be able to compete for those funds.

**The Create plan** to speed freight rail by building more bridges, underpasses and other links to avoid traffic jams will be able to complete expanded pots of money. That includes an extra \$5 billion for multimodal projects of regional and national significance and \$3.2 billion in an older program known as Infrastructure for Rebuilding America that the region has successfully tapped in recent years for other Create projects.

**Lead pipe replacement** nationally is to get tens of billions, enough according to the White House to complete such work nationally. Sen. Tammy Duckworth, D-III., has been a strong proponent of such a program, but her office said it wasn't yet clear whether the amount being prosed is sufficient to finish the job.

#### **FAR Credit Clause Waiver Gains Momentum in Senate**

ACEC Illinois has continued to work with our Congressional Delegation to seek a full and complete waiver from the FAR Credit Clause for forgiven PPP loans. Through continuous conversations between ACEC IL, ACEC National and Senator Duckworth's office—including multiple conversations within the last 7 days--her team in bi-partisan collaboration with Senator Braun (R-Indiana) is now working on potential amendment language to add on to the Bi-Partisan Infrastructure Agreement that would provide the full waiver.

ACEC IL has updated IDOT on these developments and we will continue pushing for a full National fix. Senator Duckworth's engagement on this issue in collaboration with Senator Braun represents the most advanced efforts to date to achieve a full waiver at the National level.

#### State Updates



### ACEC IL Provides Testimony to Senate Transportation Committee on Design Build

The Illinois Senate Transportation Committee invited ACEC Illinois to participate in a subject matter hearing on alternative delivery methods for transportation projects last week. ACEC IL President and CEO Kevin Artl was joined by ACEC IL member Roger Driskell (CMT), Linda Moen (EFK Moen) and Mike Mack (Burns & McDonnell).

Artl's testimony focused on four critical areas for ACEC members:

- Prioritizing Qualifications as Basis for Selection
- Utilizing Innovation and Saving Time
- Protecting Illinois' Diverse Businesses and Workforce
- Independently Procured Quality Assurance and Quality Control.

The Daily Line covered the hearing and here is a brief of their story:

**Kevin Artl, president of American Council of Engineering Companies of Illinois**, noted Illinois was one of four states that don't allow their departments of transportation to use alternative delivery methods like the design-build system.

"Some would say we're behind," he said. "I'd prefer to recognize Illinois as patient and diligent." Artl said Illinois is well positioned to evaluate how design-build has been used in other states and consider how to overcome the challenges other states faced.

Driskell said Villivalam's bill has attempted to address some of the "problems" discovered in other states that adopted design-build, including their difficulties meeting women- and minority-owned business goals.

Other witnesses, including Jacob Perez of the Illinois Hispanic Chamber of Commerce and Chetan Kale of the U.S. Minority Contractors Association, praised the bill for its provisions related to goals for women- and minority-owned businesses.

Throughout the hearing, the Department of Transportation's previous resistance to design-build appeared to be on the forefront of members' minds. Villivalam asked Holly Bieneman, director of planning and programming for the department, whether the agency and the Pritzker administration supported his bill.

"I think we're generally supportive of having it in the toolbox given the right circumstances," she said.



### ACEC IL Meets with House Republican Leader Durkin

ACEC Illinois' Chair Steve Donahue, National Director John Nelson, Incoming Chair PJ Fitzpatrick and Past Chair Orhan Ulger met with House Republican Leader Durkin and his top staff to discuss the past legislative session and emerging issues. Leader Durkin again expressed his support to protecting QBS and thanked ACEC Illinois for their engagement on that issue.

### **Agency Updates**

#### RTA approves new Capital Allocation Structure

In its July meeting, the RTA Board voted unanimously to adopt the performance-based **Capital Allocation Structure** that will guide the budget process for 2025 and 2026 funding. Chairman Kirk Dillard thanked a variety of civic organizations whose feedback during the comment period helped inform the Board's and staff's development of the process. "We have a lot of work to do, and everyone will be at the table," he said, in reference to the RTA's commitment to increasingly transparent and accountable planning and programming of projects. As development of the five-year regional budget now moves toward adoption in December, stay tuned via these **Regional Transit Updates**, RTA **Board meetings**, and the RTA **website**.


Leading up to the RTA Board action and to ensure effective stewardship of Rebuild Illinois' funds, in December 2019, the RTA Board commissioned a new Performance-Based Capital Allocation Process and a working group of RTA and Service Board staff met to develop more rigorous communications and reporting around the capital program.
