State of the Association:

Report from ACEC Illinois Board Chair Orhan Ilgaz Ulger

Dear Friends—

The last nine months have been unlike any other—a global pandemic, national discourse over social justice and an economic downturn. During times like these, communities can either fail, or rise up to the challenge.

Our community, ACEC Illinois, rose to the challenge.

- In March, as other states and cities began their lockdowns and paused or cancelled construction projects, ACEC Illinois immediately communicated with the Governor's Office, Agency Leadership and lawmakers to outline the steps our members were taking to ensure work could continue in a safe manner. As a result, the Governor declared infrastructure an essential industry and our work continued.
- To demonstrate our role in being good partners, we donated thousands of bottles of hand sanitizer to first-responders and hospitals and also worked to solicit PPE donations for front-line workers.
- As State Agencies moved to a tele-work positions, ACEC IL worked with Agency Leadership and lawmakers to expand the use of electronic signatures for contract execution, invoicing and permitting. We are working to ensure these changes remain permanent.
- To immediately assist our members with the challenges of tele-work, ACEC IL hosted a series of webinars and forums with the leadership from our Human Resources Committee and IT Committee.
- This year, we have had over 3,000 members attend our over 20 virtual updates, training sessions and conferences—an unprecedented level of engagement from our community. Our fall conference was completed without any glitches and it was totally in a virtual environment.
- We remain heavily involved on behalf of our industry on key issues, like PPP loans and its impact to our members. We are currently coordinating our efforts with neighboring ACEC organizations and trying to find a resolution to this major issue.

And while we continue to deal with the challenges of today, we remain forward-thinking.

This June our Board approved a Strategic Plan to strengthen ACEC Illinois and position ourselves as the thought leader in the infrastructure sphere. I am pleased to announce that amidst all the challenges of 2020, we are already making great progress on this plan, including:

Promoting Innovation: To reflect our membership and the needs of our clients we created new committees, including Public Engagement, Materials and Innovation. These committees will serve as thought leaders in their respective areas and will be significant resources to Agency Leadership.

Growing membership: Since July 1, ACEC Illinois has added 15 new member firms and affiliates as a proof point to the recognized leadership role our association has in the industry.

Improving the Business Climate: ACEC Illinois has been working with the Governor's Office and legislative leaders to outline key regulatory and tax reforms that will strengthen the industry.

Enhancing Educational Opportunities: ACEC Illinois staff working in conjunction with our Board is researching new, innovative educational opportunities for members. And internally, we have taken steps to optimize our operation and return to our core mission of service to our members. To highlight this, we sold our building this year, removing us from potential risk while also relinquishing all landlord maintenance duties that fell outside our core mission. Proceeds collected from the sale of the building has been put in a reserve account where the goal is to continuously save and strengthen our financial future. As a result, ACEC Illinois is in its strongest position to move forward.

To put it simply, the state of our association is strong. We have strong relationships with Agency Leadership, we are trusted sources of research and policy for lawmakers and we provide critical access and educational opportunities for our members.

Overall, the first six-months of my term as Board Chair were not quite what I had expected. But I want to thank all of you for the friendship and teamwork you have shown me, our Board of Directors, President and CEO Kevin Artl and our amazing team of Bethany Rademaker and Amanda Johnson.

It would not be right if I do not mention our President and CEO here! Most of this success throughout my term is because of his vision and fresh ideas. I would like to extend my thanks to Kevin Artl for his hard work and dedication to our industry for throughout the first-half of my term.

Together, we have demonstrated that the engineering industry is resilient and respected.

New Year Brings Some Relief to IDOT, Transit

A few days before Christmas, Congress approved a second round of stimulus funding as part of its final FY2021 appropriations package.

The legislation was the second-largest stimulus in American history, second only to the CARES Act. The measure provides substantial direct assistance to Illinois' transit agencies along with the Department of Transportation. While the legislation was the subject of veto threats and other politicization, it was ultimately signed into law by the President.

Key components of the measure will bring critical funding relief home to Illinois, specifically for IDOT and our transit agencies.

The legislation provides \$14 billion in additional transit funding. This transit funding has broad eligibility but is largely directed to cover operating expenses. Funds are distributed according to current program formulas, but when combined with CARES Act funding is capped at 75% of an agency's operating costs.

Illinois could receive upwards of \$450 million for transit agencies.

The legislation also provides \$10 billion in highway funding that will be distributed to states according to the existing apportionment formula. DOTs can use the funds for costs related to preventive maintenance, routine maintenance, operations, personnel, including salaries of employees or contractors, debt service payments, availability payments, and coverage for other revenue losses.

Based on current formula, IDOT could see in excess of \$350 million in funds from this current bill that would help offset the estimated \$250 million in MFT revenue decline during the COVID period.

Halfway There on PPP

The recent FY2021 Appropriations package also provided some clarity on PPP in terms of tax-deductibility but did not address the FAR credit issue on PPP loan forgiveness. ACEC is continuing to seek relief from the relevant federal agencies and Congress on that issue, and we are also collaborating with AASHTO and FHWA on implementation guidance on State DOT contracting. In addition, ACEC Illinois is working at a regional-level with other Midwestern states to develop guidance and clarity via MAASTO.

Here are some highlights of the tax changes in the new legislation:

- Clarifies that expenses covered by Paycheck Protection Program (PPP) loan forgiveness are tax-deductible business expenses.
- Provides a second PPP forgivable loan for qualifying businesses with 300 or fewer employees.
- Extends and expands the refundable Employee Retention Tax Credit (ERTC) and provides that employers who receive PPP loans may still qualify for the ERTC for wages that are not paid for with forgiven PPP proceeds.
- Makes permanent the Section 179D energy-efficient commercial buildings tax deduction and extends the tax credits for wind, solar, and other renewable resources.
- Extends through 2025 the Employer Participation in Repayment Act (ERPA), which allows employers to provide up to \$5,250 in student loan payments without it being a taxable benefit to the employee.

New Illinois Congressional Delegation Members Sworn-In

Illinois saw two new Members of Congress sworn-in on Sunday. Cong. Marie Newman (IL-5) and Cong. Mary Miller (IL-15). Cong. Newman defeated former Cong. Dan Lipinski in the March primary and was elected in November and Cong. Miller, also elected in November, succeeds former Cong. John Shimkus who announced his retirement.

Illinois General Assembly Set to Convene for Lame-Duck Session

The Illinois House and Senate and planning to convene from January 8th to January 13th for what is considered a "lame-duck" session before the new General Assembly is swornin on the afternoon of January 13th. The agenda for this session is unclear right now, but it is anticipated that a policy agenda being drafted by the Illinois Legislative Black Caucus will be prioritized for discussion.

The Black Caucus agenda is split among four pillars of policy: criminal justice reform, violence and police accountability; education and workforce development; economic access, equity and opportunity; and health care and human services.

In addition, ACEC Illinois has been working with State Senator Ram Villivalam on language to codify the use of electronic signatures for invoicing, contracts, permitting and other uses and we are hopeful this may be approved during the lame-duck session.

Speaker Madigan?

Speaker Madigan will preside over the lame-duck session, but as the new General Assembly gets sworn in on the afternoon of January 13th, their first order of business will be to elect a new Speaker and who that is remains entirely unclear. Most pundits believe Speaker Madigan remains 5-6 votes short of the 60 required to be elected Speaker, yet only one other candidate has announced an intention to run against him, Rep. Stephanie Kifowit, and she has no announced supporters.

Recently both the Black Caucus and the LatinX endorsed Madigan. The House cannot act on business until a Speaker is elected, for instance In 1975, it took three weeks and 93 votes of the Illinois House before Bill Redmond was elected speaker.
